- What is the overall goal to get out of each session?
- We asked 3 LDC members to sit in on each category
 - o Academic/Institutional meeting May 19th
 - o Downtown/Local Merchants May 20th
 - o Manufacturing/Industrial May 21st
 - o Focus groups to get insight and intel on potential projects, and support from the LDC. Two goals overall for focusing in on facilitating sustainable pleasing and environmentally appropriate development in key areas. 2nd goal is playing an active role in recruitment and retention of businesses and their employees.
- Questions for groups:
 1. Looking at opportunities for possible future collaboration.
 - What is taking place at the hospital? Is the change with their affiliation going to raise or lower the future opportunities over there?
 2. In regards to the larger institutions, understanding where are they having success in retention and recruitment?
 3. The opportunity for collaboration on projects and financially working with human resources with other entities. Private and public partnerships, etc
 4. A review of local area from a supply chain prospective, to local providers of supplies and the opportunity on expansion in a warehousing manufacturing perspective.
 5. How can the LDC help, where might they plug in? What is the outcome?
 6. Do individuals consider the LDC an organization they can come to for support and outreach?
 7. Is there anything we need or ability to modestly supplement the efforts of the City and its contractor and consultant on the gateway project? Maybe additional LDC support would be a good idea.
 8. Businesses themselves, and other ways at looking at it getting together in a communal way to help with development collaboratively?
 9. How do we get creative with ways to repurpose different funding sources or work with organizations whom provide funding to businesses?

Gateway Project Update

- Engineer for project is under contract moving forward on closing, initial planning board overview on project.
- One potential interest, restaurant- based but wanting to have a food access component.
